## **ARTISAN VENDORS**

As an **artisan** you are a skilled craft worker who makes or creates things by hand and would like to invite you to participate in the 2024 Hymers Fall Fair.

If you sell articles purchased for resale or articles sold commercially, please apply as a commercial vendor. The commercial vendor package is available on our website: [www.hymersfair.com](http://www.hymersfair.com).

Any food item sold at the Fair must be packaged for take home, not for consumption at the Fair. **Only approved food vendors** are allowed to distribute food and beverages.

It is recommended that vendors carry Liability insurance. This may be available through your home owner / tenant insurance policy. The Co-Operators, in collaboration with the Ontario Association of Agricultural Societies have developed inexpensive liability insurance for fair vendors, for information, visit <https://duuo.ca/vendor-insurance/oaas/> To purchase coverage for the Fair, visit <https://apps.ca.ics.duuo.ca/booth-operation/protections/list?prescriptionGroup=oaashas>

A 10 foot x 10 foot outdoor space is provided in “Artisan Alley” for \$75. You must provide your own canopy, tables and chairs. Space is limited as there are only 21 outdoor spots for Artisans. Send your application form in early to assure space is available.

Vendors must be a paid up members of the Hymers Agricultural Society or purchase a gate pass. Your helpers may either purchase a Vendor gate pass or pay admission at the gate. Gate admission is \$10 per day.

**Set-up will be on Saturday 2 pm– 4 pm; Sunday 7:30 am – 9 am.**

Vehicles must be **off** the grounds by Sunday and Monday 9 am. Vehicles will not be allowed back on the grounds until 7 pm on Sunday and 6 pm on Monday or one hour after closing. Every vendor is expected to be operational for the entire Fair.

Your receipt and purchased gate passes will be mailed out before the fair date.

A night watchman is provided Friday, Saturday, and Sunday nights. While all precautionary measures will be taken to guard against loss of equipment or display material, the Society will not be responsible for losses which might occur from pilfering, water damage, weather, fire, accident or any other causes. Concessionaires are advised to insure their own goods against any such loss.
